Volunteers have been busy enhancing the overall appearance of our community. Here are some before and after photos. Your participation is highly encouraged!

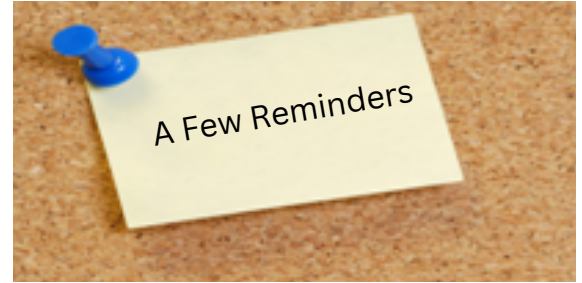


Carol Scott and Susan Nutini cleared the feature area along the walk path and planted flowers and mulched the area.
